3. DISCLOSURE OF PERSONAL INTEREST

Clir R.Phillips declared an interest when the planning application A071312CD was discussed (Point 9 in the minutes).

4. THE PRECEPT FOR THE NEXT FIANCIAL YEAR

It was decided that the precept for the next financial year would remain the same as the previous year i.e. at £43,220. This represents a payment of £48.96p.a. for the Band D Rate-Payer.

 - 5.7 Leasing the Old Primary School as an amenity for the people of Lampeter: developments ongoing between the Town Council and Ceredigion County Council.

- 5.8 **Town Council Election May 2008:** the cost of £1,000 would have to be accommodated within the budget, in the event of an election. -noted for information.
- 5.9 **Tourist Information Centre:** not discussed.
- 5.10 Working in Partnership with the CCC to deliver certain projects: not discussed.
- 5.11 Training for Clerks and Councillors: not discussed.
- 5.12 Nationally Negotiated Wage Settlements (for Clerks): not discussed.

5. **DONATIONS TO CHARITY**

It was highlighted that £9,024 was the maximum sum, which could be donated to charity in 2007-08. Actual donations to 31 December - £4,333.
