1. **PRESENT:** Mayor Cllr Hag Harris; Cllr Chris Thomas; Eleri Thomas (Clerk: Lampeter Town Council).
2. **APOLOGIES FOR ABSENCE**  
Cllr Elin T Jones; Lizzie James & Cllr David Smith apologized for their inability to attend the meeting.
3. **DISCLOSURES OF INTEREST:** None declared.
4. **THE MINUTES OF THE PREVIOUS MEETING OF THE 28<sup>th</sup> SEPTEMBER 2017**  
These were agreed to be a correct record and were signed by the Chairman.
5. **MATTERS ARISING**
  - 5.1 **MONEY RAISED DURING A FUND-RAISING ACTIVITY IN 2010 (£611)**  
Cllr Harris had obtained a Quote from Mr Alec Page for a pair of junior goalposts with ground pegs, painted white, Cost £460. Dimensions 4m length x 1.3m deep x 1.3 m high. Hooks will be also provided. Safety concerns had been expressed by some residents of Maesyderi Estate in relation to the goalposts. Advice had been awaited from ROSPA. It was **RESOLVED** to contact Rospa, once again (Cllr Chris Thomas).
  - 5.2 **Annual Inspection of the Field:** The **ROSPA** Play Area Inspection will take place during the summer of 2018.
  - 5.3 **Grass Cutting of the Field during the 2018 Season** (April-September):  
Tenders have been sought and will be considered further at the main meeting of the Town Council (to follow this meeting).
  - 5.4 **Fence:** Cllr Chris Thomas had reattached a part of the fence to the post. Fence in need of repair at the far end of the field.
  - 5.5 **Dog Fouling:** A Bye Law could be introduced by Ceredigion County Council in the future to prohibit dog-owners from walking their dogs on the field.
  - 5.6 **Brambles:** Mayor Cllr Hag Harris had cleared the brambles from one section of the field.
  - 5.7 **Past & Present use of the field:** Past users have included the School, RAY Ceredigion and certain Football teams. Present Use: Informal use; amenity area and periodic events.
